# LIMITED 10-YEAR WARRANTY

JP Lamborn Company warrants that all of its UL-181 Flexible Air Ducts (the "Product") will be free from defects in materials and workmanship under normal use for a period of ten (10) years from date of manufacture. This warranty shall apply only to the Product when installed in the U.S.A. in accordance with JP Lamborn Company's written installation instructions and within the conditions and limitations of the published performance data. Any implied warranties for the product are limited to 90 days. "Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you. The ten (10) year warranty described herein is effective with respect to JPL UL-181 Flexible Air Ducts manufactured by JP Lamborn Company on or after August 1, 2005.

JP Lamborn Company does not warrant: (1) Defects caused by failure to provide a suitable storage and installation environment for the Product, including, but not limited to, defects caused by the failure to protect the Product from exposure to outdoor elements; (2) Damage caused by the use of the Product for purposes other than those for which it was designed; (3) Damage caused by disaster such as fire, flood, wind, and lightning; (4) Damage caused by unauthorized attachments or modifications; (5) Damage during shipment; or (6) Any other abuse or misuse of the Product.

Customer Remedies. If a purchaser discovers within the applicable warranty period of a failure of the Product to conform to specifications, or a defect in material or workmanship, the purchaser must promptly notify JP Lamborn Company in writing. JP Lamborn Company's entire liability and the purchaser's exclusive remedy shall be, at JP Lamborn Company's option, either return of the purchase price or repair or replacement of the defective Product. These remedies are the purchaser's only remedies for breach of warranty. Any replacement Product will be warranted for the remainder of the original warranty period or one (1) year, whichever is longer.

Limitation of Remedies. In no event will JP Lamborn Company be liable for any special, incidental, or consequential damages based on breach of warranty, breach of contract, negligence, strict tort, or any other legal theory. Damages that JP Lamborn Company will not be responsible for include, but are not limited to, loss of profits; business interruption; loss of savings or revenue; loss of use of the Product or any of the associated equipment, cost of capital; cost of substitute equipment; facilities, or services; downtime; the claims of third parties including customers; and injury to property arising out of the use or inability to use the Product, even if JP Lamborn Company has been advised of the possibility of such damages. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.

No other Warranties. The foregoing warranties are in lieu of all other warranties, express or implied, including but not limited to the implied warranties of merchantability and fitness for a particular purpose JP Lamborn company disclaims all other warranties, either express or limited, including but not limited to the implied warranties or merchantability and fitness for a particular purpose with respect to the product the limited warranty gives the purchaser specific legal rights.
